Distributionally Robust Two Stage Stochastic Programming

We study two stage stochastic programs with linear recourse under distributional ambiguity, and we formulate DRO models that vary in how the ambiguity set is built, focusing on the Wasserstein distance, allowing the support of the random variables to be a continuous space. We study both unbounded and bounded support sets, and provide guidance regarding which models are meaningful in the sense of yielding robust first stage decisions, and how to solve the resulting models. This is joint work with Daniel Duque and Sanjay Mehrotra.
